My Retirement Plan website

We are currently in the process of launching a new website called My Retirement Plan, which will be available to *active members* of the Teachers' Pension Plan (Plan).



Access your pension information online!

My Retirement Plan offers secure access to personal pension information at the Plan member's convenience. Plan members can:

- View their Personal Annual Member Statement;
- Use the Pension Projection Tool to estimate how much their pension could be;
- View their personal data; and
- View helpful retirement and financial planning resources.

Active Plan members will be given access to the website. We will be sending all active Plan members personalized letters containing Member IDs and passwords in a phased approach, beginning in July 2015 through to December 2015.

2015 Annual Member Statement

TPP Member Statements were mailed to all active contributing Plan members in May.



TPP Member Statements have been redesigned!

These Statements are now printed on white paper (replacing the previous blue paper Statements). The new 3-page Statements include:

- A summary of personal information
- · Retirement dates
- Benefits at retirement
- Accrued pension
- Termination benefits
- · Survivor benefits, and more!

We have created an *Instructional Guide* to help Plan members better understand the information provided in the newly designed Statements.



REMINDER! Contribution rate increase

On August 1, 2015, member and matching employer contribution rates shall increase by 1 per cent.

Contribution rate increases were announced last year as part of the 2014 TPP changes that were implemented by the Teachers' Pension Board.

The changes included an increase in both member and employer contribution rates by 1% per year for three years. The chart below details these contribution rate increases:




*Year's Maximum Pensionable Earnings

REMINDER! Retiring Teachers

One of the most important things for Plan members to remember about preparing for retirement is that they must apply for a pension. Retiring teachers are not paid automatically upon retirement. Please remind retiring teachers to contact Pension Services Corp. three months prior to their planned retirement date to initiate their retirement.

The Plan had a total of 31,472 members (as at December 31, 2014)



The Plan had 0.995 active members for every 1 retiree

In the past 5 years, the number of active Plan members has been declining and there are now more retirees than active members.

A low ratio of working-to-retired teachers creates a greater impact on active Plan members to cover any shortfalls or investment losses.

* Includes Plan members who have not contributed to the Plan in the past year and a half and have not retired or removed their funds from the Plan.



Plan funded ratio as at December 31, 2014

The Plan's funded ratio

increased to 77.3 per cent from 75.0 per cent in 2013.

A funded ratio of 100 per cent or more would mean that the Plan is fully funded.
